II. <u>Declaration of clusters as Planning Areas</u>

Andhra Pradesh

- 3 of the NRuM clusters fall under the jurisdiction of the Integrated Land Use Plans (ILUPs), prepared for the respective sub districts/Mandals.
- Only Kambadur sub district does not have a ILUP prepared.
- Hence, the way forward suggested by the T&CP department is that for Kambadur, the delineation would have to be done and sent to the T&CP department for preparation of a ILUP. For the remaining clusters as they fall under the jurisdiction of an already drafted ILUP, these clusters need not have a separate delineation done. Only in case the components chosen under the NRuM deviates from the ILUP there needs to be an approval take from the T&CP department for the same.
- Further, it was highlighted by the T&CP department that an amendment needs to be done in the AP Panchayati Raj Act, 1994 to give legal validity to these ILUPs covering the rural areas.

Kerala:

- Master Plans are being prepared for each GP in the State.
- The Town Planning department has confirmed that Master Plans have not been prepared for any of the GPs selected under the NRuM.
- As per discussions with the T&CP department, the way forward advised for declaration of these clusters as planning areas was that RD department would need to write to the T&CP department to initiate the Master Planning process in these GPs.

Karnataka

• All the clusters selected under NRuM fall within the jurisdiction of an existing Master Plan and hence the State need not delineate these clusters as planning areas separately.

Tamil Nadu

- It was confirmed by the Planning department representatives that all the clusters selected under NRuM fall within the jurisdiction of an existing Master Plan.
- Hence there is no need for separate delineation of the clusters as planning areas.

<u>Telengana</u>

- Final confirmation from the Planning department on whether these clusters selected under the NRuM fall under an existing Master Plan or not needs to be given by the T&CP department.
- The RD department would have to intimate the T&CP department on the list of revenue villages covered under the NRuM cluster in response to which T&CP department would initiate the preparation of ILUP for these sub districts.
