- (v) Funds should not be diverted for any purpose other than as mentioned at (i) & (ii) above.

The accounts of the grantee institutions will be audited by the Comptroller and Auditor General of India and the Internal Audit of the Principal Accounts Office of the Ministry of Rural Development under Chief Controller of Accounts, in terms of Rule 236 (1) and 236 (2) of the General Financial Rule 2017.

- 3. This is the first release for Third Phase Clusters; no Utilization Certificate (UC) is pending.
