- (viii) Furnishing of Utilization Certificate for 60% of the amount released following the heads indicated in (i) to (v) above.
- (ix) The corresponding State Share of Rs 9.00 crore is to be released as soon as the Central Share is received in the Rurban -SNA account.
- (x) The release of funds is subject to audit by Internal Audit of Department of Rural Development.
- 2. The State should submit the expenditure statement of funds released earlier for ICAP preparation.
- 3.
