- (iii) The funds should be utilized as laid down in the framework of implementation of the SPMRM.
- (iv) The release of funds is subject to audit by Internal Audit of Department of Rural Development.
- (v) Funds should not be diverted for any purpose other than as mentioned at (i) & (ii) above.

4. The expenditure is debit to the following Head of Accounts under Demand No.82 Department of Rural Development (2018-19).






