- (vi) Furnishing of Utilization Certificate for 60% of the amount released following the head (i) above.
- (vii) The corresponding State Share of Rs 16.20 crore is to be released as soon as the Central Share is received in the Rurban -SNA account.
- (viii) The release of funds is subject to audit by Internal Audit of Department of Rural Development.

2. The State has submitted the Utilization Certificate (UC) for the Financial Year 2016-17.

3. The State should submit the expenditure statement for 1st and 2nd installment released.

4. The accounts of the grantee institutions will be audited by the Comptroller and Auditor General of India and the Internal Audit of the Principal Accounts Office of the Ministry of Rural Development under Chief Controller of Accounts, in terms of Rule 236 (1) and 236 (2) of the General Financial Rule 2017.


