- Initiation of the Master Planning process for each cluster in consultation with the town (v) planning department of each State. (vi)
- Funds should not be diverted for any purpose other than as mentioned at (i) to (v) above.
- (vii) Furnishing of Utilization Certificate for 60% of the amount released following the heads indicated in (i) to (v) above.

(viii) The release of funds is subject to audit by Internal Audit of Department of Rural Development.

The State should submit the expenditure statement for Rs 70 lakh immediately as released 3. earlier for ICAP preparation.

The accounts of the grantee institutions will be audited by the Comptroller and Auditor 4. General of India and the Internal Audit of the Principal Accounts Office of the Ministry of Rural Development under Chief Controller of Accounts, in terms of Rule 211 (i) and 211 (2) of the General Financial Rules.

5. This is the first instalment. Hence, no Utilization Certificate (UC) is pending.
