Sir,

I am directed to convey the sanction of President of India to the payment of Grants-in-aid amounting to Rs. 16,20,00,000 (Rupees Sixteen Crore Twenty lakh only) to the State Government of Gujarat as Central Assistance for the following SPMRM clusters:

2. **The next release will be made on fulfilment of the following conditions:-**

- (i) Preparation of DPR for all CGF components.
- (ii) Commencement and completion of all soft components for which DPR preparation is not required, such as training modules for all skill development activities, purchase of equipment, procurement of cabling lines etc. -such components would be identified for each cluster in consultation with the Ministry.
- (iii) Setting up of the State Project Management Unit-SPMU with at least 3 professionals as per qualification criteria mentioned in Framework of Implementation.
- (iv) Setting up of the District Project Management Unit and/or Cluster Development Management Units as decided by the State with each unit manned by at least 2 professionals as per qualification criteria mentioned in Framework of Implementation.

- (v) Initiation of the Master Planning process for each cluster in consultation with the town planning department of each State.
- (vi) Funds should not be diverted for any purpose other than as mentioned at (i) to (v) above.
- (vii) Furnishing of Utilization Certificate for 60% of the amount released following the heads indicated in (i) to (v) above.
- (viii) The release of funds is subject to audit by Internal Audit of Department of Rural Development.
3. The State should submit the expenditure statement for Rs 140 lakh immediately as released earlier for ICAP preparation.
4. The accounts of the grantee institutions will be audited by the Comptroller and Auditor General of India and the Internal Audit of the Principal Accounts Office of the Ministry of Rural Development under Chief Controller of Accounts, in terms of Rule 211 (i) and 211 (2) of the General Financial Rules.
5. This is the first installment. Hence, no Utilization Certificate (UC) is pending.
6. The expenditure is debit to the following Head of Accounts under Demand No. 75 Department of Rural Development (2016-17).
