2. The State should submit the expenditure statement for 1st and 2nd instalment released.

3. The State Share of Rs 32.40 crores towards first and second instalment, should be released by the State into the SPMRM head of account in the State treasury within 2 weeks of this release.

4. The accounts of the grantee institutions will be audited by the Comptroller and Auditor General of India and the Internal Audit of the Principal Accounts Office of the Ministry of Rural Development under Chief Controller of Accounts, in terms of Rule 211 (i) and 211 (2) of the General Financial Rules.
