- II. Apart from (i) above, if the State so desires, these funds may also be utilized for setting up initial institutional arrangements for SPMRM in the State.
- III. The funds should be utilized as laid down in the framework of implementation of the SPMRM.
- IV. The release of funds is subject to audit by Internal Audit of Department of Rural Development.
- V. Funds should not be diverted for any purpose other than as mentioned at (i) & (ii) above.
