I am directed to convey the sanction of President of India to the payment of Grants-in-aid amounting to Rs. 4,05,00,000 (Rupees Four Crore Five Lakh only) to the State Government of Mizoram as Central Assistance for the following SPMRM cluster under Phase 2:

The next release will be made on fulfilment of the following conditions:-

- Preparation of DPR for all CGF components.
- Submission of DPR template duly authorized by SLEC.
- Release of State share of Rs 45.00 lacs into SPMRM head of account in the State treasury within 2 weeks of this release.
- Commencement and completion of all soft components for which DPR preparation is not required, such as training modules for all skill development activities, purchase of equipment, procurement of cabling lines etc. -such components would be identified for each cluster in consultation with the Ministry.
- Setting up of the State Project Management Unit-SPMU with at least 3 professionals as per qualification criteria mentioned in Framework of Implementation.
- Setting up of the District Project Management Unit and/or Cluster Development Management Units as decided by the State with each unit manned by at least 2 professionals as per qualification criteria mentioned in Framework of Implementation.
- Initiation of the Master Planning process for each cluster in consultation with the town planning department of each State.

(viii) Funds should not be diverted for any purpose other than as mentioned at (i) to (v) above.

(ix) Furnishing of Utilization Certificate of the amount released following the heads indicated in (i) to (v) above.

(x) The release of funds is subject to audit by Internal Audit of Department of Rural Development.

2. The State should submit the expenditure statement for Rs 35 lakh immediately as released earlier for ICAP preparation.

3. The accounts of the grantee institutions will be audited by the Comptroller and Auditor General of India and the Internal Audit of the Principal Accounts Office of the Ministry of Rural Development under Chief Controller of Accounts, in terms of Rule 211 (i) and 211 (2) of the General Financial Rules.

4. This is the first instalment. Hence, no Utilization Certificate (UC) is pending.

5. The expenditure is debit to the following Head of Accounts under Demand No. 75 Department of Rural Development (2016-17).
