- (iii) Fully functional District Project Management Unit or Cluster Development Management Units as decided by the State with each unit managed by adequate number of professionals as per qualification criteria mentioned in Framework of Implementation.
- (iv) Completion of Draft Master Plan for each cluster.
- (v) Funds should not be diverted for any purpose other than as mentioned at (i) to (iv) above.
- (vi) Furnishing of Utilization Certificate for 60% of the amount released following the heads indicated in (i) to (v) above.
- (vii) The State should submit the expenditure statement for 1st and 2nd installment released.
